

### **Keeping dogs on a leash**

At the campsite and at the beach all dogs must be kept on a leash. This rule also applies when driving a bicycle or jogging. Dogs can move more freely in areas where 8 m long leashes (for example stretchable leashes) are allowed.

### **Safe-keeping of dogs**

When kept near a tent, a camper, a caravan or a mobile home, dogs must be on a leash so that they are unable to leave their camping spot by themselves (for example on an 8 m leash).

### **Encounters with other guests**

If other guests or dogs owners are approaching, dogs are to be kept on a short leash even without this being requested by the other person. In order for two dogs to come close to each other - whether on a short or a long leash or without one - b o t h owners must agree to this.

### **No disturbance and night hours**

Dogs must be kept in such a way that they do not disturb other guests or dogs by constantly barking, growling, howling or through other unpleasant behaviour. Night hours are from 22:00 to 7:00 – and they must be noise-free.

### **Behavioural problems**

Dogs that endanger other guests or dogs cannot be let into the camp. Problematic behaviour must be reported when registering at the camp.

### **Safe-keeping in case of absence of the owner**

If the owner is temporarily absent, the dog has to be on a leash and the owner must make sure that he is safely kept in a kennel or inside the camper or mobile home.

### **Dog waste disposal**

If possible, dogs are to be taken outside of the campsite to defecate. The owner must pick up the waste using a bag and then place it in the provided dog waste receptacles.

### **Beach and swimming**

Keeping dogs on the beach and swimming is allowed only in areas that are marked in blue. At the beach dogs must be kept on a leash tied to a hook.

### **Control, fines and expulsion from camp**

Compliance with the Camping Cum Cane® rules is subject to control, offences are penalised with up to 120,00€ fines or by expulsion from the camp. Reimbursement of the remaining nights will not be granted.

## A What is “Camping Cum Cane”?

“Camping-Cum-Cane”® (Camping with Dogs) makes it possible for both guests with dogs and those without one to have the best possible vacation. The project received great praise from the ADAC (German Automobile Club) and was given the prestigious ADAC-Camping-Award for significant novelties in the camping-caravanning sector. Other awards followed soon after.

The basis of the concept Camping-Cum-Cane (CCC) is the motto: “Pleasant camping vacations for guests with dogs and those without one”. Besides rules for dog owners, the CCC project includes a dog-friendly infrastructure, a dog training course specially designed for guests who are dog owners, individual and group lessons, as well as various events and competitions conducted by the CCC licensed trainer - Dragan Sanković.

Since 2019 participating in the Camping-Cum-Cane project is also possible in Punta Križa (Cres-Croatia), at the naturist campsite Baldarin.

## B What does the “Camping-Cum-Cane”® project have to offer

- **Info panel for Camping-Cum-Cane** explaining the infrastructure and rules
- **Safety requirements** thanks to the obligation of keeping dogs on a leash (1.5 m long or stretchable and 8 m long)
- **Dog waste disposal stations:** posts (with bag dispensers and waste receptacles) at short distances
- **Sea and beach access** within a special dog swim area with safe concrete entrance and hooks for leashes
- **Hygiene stations:** dog showers, hair care
- **Lesson held by a CCC-licensed** coach twice a week in groups or individually regarding the following topics: campsite manners, activities, sports and various events
- In case of emergency a **local veterinarian** can be called (additional charge).

## C “Camping-Cum-Cane”® rules :

### Identification tags:

While at the campsite or at the beach dogs have to wear their identification tag the whole time. (Subject to control! Possible fines and expulsion in case of repeated violation of the rules.)

### Avoiding risks

Avoiding risks is a priority! “Relax, my dog won’t hurt you” is not an acceptable attitude! Therefore dogs must be held on a leash in order to guarantee physical and psychological safety of other guests.
